**Re: IMLC Rule Chapter 6 Comments**

Dear Rules and Administrative Procedures Committee of the Interstate Medical Licensure Compact Commission,

On behalf of the Washington State Medical Association (WSMA), representing over 12,000 physicians and physician assistants across Washington state, we appreciate the opportunity to provide comment in support of the proposed amendments to IMLC Rule Chapter 6. The WSMA recognizes abortion as an essential component of reproductive health care and supports the right of physicians to include abortion as part of their practice and of patients seeking to access the full range of reproductive health care services.

Despite the Supreme Court decision in *Dobbs v. Jackson Women's Health Organization*, abortion services in Washington state remain legal, however that is not the case for all states. The resulting patchwork of legality and interconnectedness of Compact states creates new complexities. The proposed amendments will offer some additional safeguards to help ensure physicians licensed through the Compact who are performing lawful services in states where abortion is legal are protected from discipline and other repercussions that could be pursued by states with restrictive abortion laws under current Compact rules. We are thankful the Commission is responding to this changing landscape and recognize that there will likely need to be additional efforts taken to protect these physicians as we continue to learn about the widespread impacts of the ruling.
